1. The **Petroleum Authority of Uganda** has planned and allocated funds to be used for the acquisition of **Newspapers under Framework Contract for a Period of One Year renewable once Upon Satisfactory Performance.**
2. The Entity invites sealed bids from eligible bidders for the provision of the above supplies.
3. Bidding will be conducted in accordance with the **Open Domestic Bidding** method contained in the Public Procurement and Disposal of Public Assets Act, 2003, and is open to all bidders subject to the PPDA guideline on reservation schemes to promote local content.
